Financial Statements

The Board reviewed the monthly financial statements. Chief Dahlman stated that projected tax revenue received is at 88%. At 41% of the way into the year, we are at 38.1% of the budget. Dispatch is at 50% but should level out. Station 14 Maintenance and Repair is at 79%.

<u>Item #1 – Resolution #2024-12 Appropriate Conflagration Funds</u>

The Board reviewed Resolution #2024-12 Appropriate Conflagration Funds in the amount of \$45,000.00 (4710) received from the State of Oregon to the following accounts:

Item #2 - Review Policy 11.2 Apparatus Driver / Operator Driving Violations

The Board reviewed the changes made to Policy 11.2 Apparatus Driver / Operator Driving Violations. Changes include individuals now being permitted to drive Code 3 one (1) year after a Class A violation instead of three (3) years, and individuals with a combination of three (3) Class B violations/convictions will now receive a warning letter from the District as opposed to being suspended from driving District vehicles for 90 days.

Dan Drayton made a motion to approve the changes made to Policy 11.2 Apparatus Driver / Operator Driving Violations as presented; Nancy Oksenholt seconded the motion. The motion passed. (See Motion #4)

<u>Item #3 – Review Policy 6.4 Accounting Practices</u>

The Board reviewed Policy 6.4 Accounting Practices. This is a newly drafted policy based on the annual audit's Accounting Walk-through. It also addresses the implementation of a quarterly audit in which the Board Secretary/Treasurer will directly contact the District Accountant to run an audit of two (2) or three (3) selected General Ledger accounts over a three-month period.

Nancy Oksenholt made a motion to approve Policy 6.4 Accounting Practices as presented; Dan Drayton seconded the motion. The motion passed. (See Motion #5)

<u>Item #4 – Resolution #2024-13 to Appropriate Donation Funds</u>

Chief's Report

Chief Dahlman went over some of the highlights of his report which was included in the Board packet:

- EMS report:
 - 9 transports in November
 - Ambulance transport dollars received FY 2024 / 2025 is \$10,548
 - o Outstanding billings from PWA are continually reviewed to close out our relationship
 - Tactical Billing has 34 transport billings in process, plus 3 more PWA failed to bill

- Monies received in November:
 - \$ 3,282 Ambulance collections
 - \$ 2,800 STR Inspections
 - o \$ 922 EF Recovery
 - o \$ 3,500 Surplus Equipment
 - \$ 1,800 Plan Review fees

• Building and Equipment Maintenance:

- All generators have been tested and serviced. Interior cleaning and repairs. Roofs winterized.
- o Pump testing was completed on all fire pumps; no issues found, all passed.

Annexations:

30 letters were sent (affecting 39 properties on Hwy. 229 and in the Roads End area).
 To date we have received 16 consents for annexation. We submit paperwork to the Department of Revenue; they approve and send it back to the County and it's on the tax roll.

Alarm Responses:

280 alarm responses in November, up from 246 alarms in November 2023, a 13% increase. 3,115 alarms to date in 2024, up .5% from 3,103 this time last year.

Financial Audit:

 No draft Audit yet; additional information has been requested and sent along with a letter asking if we are subject to any current litigation. The attorneys have responded.

OSFM Conflagrations:

 We received another \$50,419 from the OSFM preposition assignment. All conflagrations have been billed to OSFM, pending reimbursement is \$19,707.

Personnel and Hiring:

- Seven Volunteers are in first-year training, four of them are water rescue only. Roster now has 20 active Volunteers and four Support Volunteers (Chaplains/Inspector). Letters have gone out to inactive Volunteers to either increase their activity with the District or be removed from the roster. In response, a couple of them have increased their activity with the District.
- One pending Volunteer application.

Ladder Truck:

 We objected to the insurance valuation of \$286,477. I sent back additional information, and the valuation was increased to \$337,717, an increase of \$51,240. We have received the check and Special Districts Insurance Services (SDIS) has also started paying for the equipment that had been destroyed and replacements have been ordered.

FYI Information:

- The joint City/NLFR meeting seemed to go well. We are working with the City on the SW 51st beach property.
- We sold the 1999 white Ford pickup at the Kelly Blue Book value of \$3,500.
- We were contacted by an anonymous person who wants to donate again this year. They will cover the cost of a new jet ski and a Lucas CPR device.

- No ISO information back yet.
- Grants:
 - ➤ We applied for and received the SDIS 50/50 matching grant for \$2,500. It will be used for lighting the new fenced area at Station 16 and adding bay cameras at four (4) stations.
 - We are also applying for a grant for a fire extinguisher electronic prop, will ask for a letter in support of from the Lincoln County School District (to be used for Teen Cert training) and the Casino for training their staff.
 - We are once again applying for an AFG grant for turnouts, with a few modifications from earlier applications.
- We put out Beach Hazard signs on Saturday in anticipation of the king tides this weekend. Warnings have also been posted on our electronic signs and social media.
