## Item #1 – Surplus of 2012 Kawasaki Jet Ski

The current system is outdated and unable to be serviced and maintained. The funds will come out of Bond Facilities and Upgrades.

Nancy Oksenholt made a motion to approve the purchase and installation of a new fire alarm system for Station 15 from Iconipro for \$21,795.00 (plus permits); Dan Drayton seconded the motion. The motion passed. **(See Motion #8)**

# Chief's Report

Chief Dahlman went over some of the highlights of his report which was included in the Board packet:

- EMS report:
  - 1 transport in January
  - o 71 transports in some level of billing with PWA
  - Ambulance transport dollars received FY 22/23 is \$38,389

## • Monies received:

- \$ 1,052 EF Recovery
- \$ 15,500 Ambulance collections
- \$ 100 Fire Marshal fees

- EF Recovery:
  - NLFR is adding to EF Recovery billing to collect our fines for fire code and alarm violations.
  - 2022 Year End Summary 96 claims, collected \$22,210.
- Building and Equipment Maintenance:
  - Bob serviced and tested all the station generators after recent storms.
  - Bob Wentz (former Support Services) completed Quarterly Facility Inspections, forwarded to Bob who corrected any issues.
  - Kenny working on multiple vehicle maintenance.
- Alarm Responses:
  - o 285 calls in January 2023, down 13% from January 2022's 314 alarm responses.
- Urban Renewal:
  - City of Lincoln City has started the process for another Urban Renewal District, this one in Nelscott. Plan A (172 acres) or Plan B (350 acres) will freeze today's value for the next 25 years, impacts our budget significantly – 97% of our funding comes from property taxes.
- Grant applications:
  - 2022-23 SDAO Safety and Security \$5,000 grant for security lighting at Stations 12, 13, and 17 is being rebid as proposal was not what we had asked for.
  - OSFM Tender Request submitted, no word yet.
- Bond Purchases:
  - All new engines are in service.
  - No update on ambulance build.
- Personnel and Hiring:
  - Hired FF/EMT Trent Rainforth, assigned to C-Shift.
  - Currently accepting applications and test results from National Testing Network, closes the end of February. Will be interviewing and hire immediately afterwards.
  - Three new volunteers finishing first year training. 19 active Volunteers on the roster; lost 2 (one moved and the other has work commitments out of the area).
- Surplus Property:
  - The second engine only received \$5,850 in bids on Govdeals, Chief will contact State Surplus to see what they can do.
  - Toledo Fire Department and Georgia Pacific Mill are interested in purchasing HR-16, Chief will contact them. We don't use it, have enough equipment without it, will declare as surplus.
- Casino Meeting:
  - Chief Dahlman met with the new General Manager, Harold Baugus, on January 17<sup>th</sup>, and it went very well:
    - Mr. Baugus would like to implement a 190 Agreement or MOU.

- Mr. Baugus agrees a fee increase is in order.
- We will compile a list of services the District can provide the Casino and Mr. Baugus will make a presentation to Tribal Council and if they approve, we will move forward.
- Their proposed new 7-story motel is delayed 5-6 years so they can repair/maintain the existing motel.
- Out-of-District Properties:
  - Of the 11 letters sent out, 1 resulted in a completed contract (\$1,408), 1 is pending and 1 is being signed at this Board meeting.
  - There is a new one on Hwy. 229, just past the annexation we did about a year ago.
- Budget Process:
  - Budget requests are being evaluated.
  - PERS and Medical/Dental Insurance are increasing 4%.
- FYI Information:
  - Awards Banquet will be held on March 25<sup>th</sup> at the Beach Club.
  - Captains Testing postponed until March 16<sup>th</sup> & 17<sup>th</sup> to satisfy Civil Service Rules.
  - The Depoe Bay Fire Chief wants to revisit some of the things that were talked about several years ago when our two departments were looking at merging. The consensus of the NLFR Board was that the current Mutual Aid Agreement is sufficient, and they have no interest in taking this up again.
